- 1) Artist agrees to be present for the duration of the market.
Market hours are 3-6 PM on Wednesdays and 7AM – noon on Saturdays.
- 2) Booth set-up must be completed by 7:30 am Saturdays and 3:00 pm Wednesdays.
- 3) No pets in artist booth.
- 4) Artists must have a valid California Resale Certificate.

10 ft wide and larger spaces are available on east side of market only.

Artists located under the arbor will have spaces approx 7 ft wide X 10 deep.
